#### **COOKIE POLICY**

The <u>Privacy Policy</u> of LELIT srl a socio unico, (hereinafter, "LELIT") explains how we collect, use or otherwise process personal data when you access or use the LELIT websites, mobile applications, and other products and services (collectively, the "Services"), or when you otherwise interact with us.

Our websites use cookies, pixel tags and other forms of identification and local storage ("tags/files") to distinguish you from other users of our website and of websites of our network (collectively our "Websites"). This helps us provide you with a good experience when you browse our Website and allows us to improve our Services. We provide this "Cookie Policy" as part of our Privacy Policy to inform you about the types of cookies and other tracking technologies we use, why we use them and your choices in relation to them.

# **Tracking Technologies We Use**

Cookies are small data files downloaded to your hard drive or mobile device when you visit a website that help us remember things about you so that we can improve our Services and customize your experience. There are different types of cookies.

Cookies may be classified according to who operates the domain from which they are set. For example, cookies served by the entity that operates the domain you are visiting (for example, ChefSteps.com) are called "first-party cookies." Cookies served by other non-affiliated companies are called "third-party cookies." We allow third parties to set cookies when you visit our Services to understand how you interact with our Services and for other reasons, as explained further below.

Cookies may also be classified by their lifespan. For example, cookies that last only for the duration of your browsing session are called "session cookies." "Persistent cookies" remain on your computer after you close your browser or after you navigate away from our webpages. Persistent cookies are stored on your device's hard drive until a specified expiration date, which could be tomorrow, ten years from now or permanent to the specific device unless overwritten with newer cookies or manually removed by you.

Some cookies may be purely technical cookies that are required to provide you with certain services. For instance, technical cookies remember the items you include in an order or allow you to share content on social networks. Other technical cookies allow us to do things like understand user behavior on our Services or serve customized ads.

"Web Beacons" and "Pixel Tags" are electronic images embedded in a webpage or email that can retrieve certain information about your device and browser, such as the device type, operating system, browser type and version, website visited, time of visit, referring website, IP address and other similar information. These technologies also help us to deliver cookies, count visits, and understand campaign effectiveness.

Local storage refers to other places on a browser or device where information can be stored, and includes both your own device storage and browser cache.

Software Development Kits (also called SDKs) are blocks of code provided by third parties that are installed in our mobile apps. They function like cookies and pixels, allowing those parties to collect (and share with us) information about how users interact with our apps as well as certain information about the device and network they use to access our apps.

## **Our Use of Cookies**

We use first-party or third-party cookies and similar tracking technologies to collect data, including personal data, for a variety of purposes, including to improve the functionality of our Services.

Below you can learn about the categories of cookies that we use and the general purpose of each category:

Category of Cookies	Purpose
Technical/strictly necessary	These cookies are essential for you to browse the website and use its features, such as accessing secure areas of the site. Cookies that allow web shops to hold your items in your cart while you are shopping online are an example of strictly necessary cookies. These cookies will generally be first-party session cookies. While it is not required to obtain consent for these cookies, what they do and why they are necessary should be explained to the user.
Preferences/functionality	These cookies allow a website to remember choices you have made in the past, like what language you prefer, what region you would like weather reports for, or what your user name and password are so you can automatically log in.
Performance/analysis	These cookies collect information about how you use a website, like which pages you visited and which links you clicked on. None of this information can be used to identify you. It is all aggregated and, therefore, anonymized. Their sole purpose is to improve website functions. This includes cookies from third-party analytics services as long as the cookies are for the exclusive use of the owner of the website visited.
Advertising/Marketing	These cookies track your online activity to help advertisers deliver more relevant advertising or to limit how many times you see an ad. These cookies can share that information with other organizations or advertisers. These are persistent cookies and almost always of third-party provenance.

# Social Media Cookies

We may use social media tools, like widgets and plug-ins, which are third party cookies, so you can share information from LELIT on other sites such Facebook, Instagram and Twitter. These cookies or widgets collect your IP address, record the pages you visit on our Services and set cookies that will enable the widget to function properly. Your interactions with these widgets and plug-ins are governed by the privacy policy of the company providing them, not by LELIT's Privacy Policy or this Cookie Policy. We may use pixel tags of third-party platforms (Such as Facebook, Instagram and Twitter) to help us understand how effective our marketing is on those platforms. Currently these pixel tags and plug-ins do not collect personal data.

To refuse these various types of cookies, please follow the instructions below under the section "Your choices".

## Duration of storage of cookies on your device

The duration of storage of cookies on your device may vary, depending on the category to which they belong: temporary or permanent.

## **Temporary cookies**

We use temporary cookies on all of our secure pages to assign and register a session ID. You can browse our entire Site without interruption. This identifier is also used for internal reporting purposes. It does not allow us to identify you by name and this type of cookie does not leave any information recoverable on your hard drive. Most of our proprietary cookies fall into this category and expire when you close your Internet browser.

#### Permanent cookies

Our proprietary analysis cookies and third-party cookies are permanent cookies. They allow us to understand visitors' browsing behaviour over a longer period of time or to provide you with additional features related to your Site customisation requests and the content that you have saved or stored. They can stay on your computer for 24 hours, a week or several years, depending on their function. This means that these cookies survive after your browser is closed and can be used by our Site to recognise your computer when you reopen your browser later.

## Your Choices—Disabling and Deleting Cookies

## Cookie management tool

We only place cookies on your device after you give us permission. In LELIT.com domains for the European Economic Area, you have the option to adjust what cookies you allow us to place on your browser through our Cookie Consent tool. You can modify these settings at any time.

#### COOKIE PREFERENCE CENTER

All cookies by web browsers: Most web browsers and devices are set to accept cookies by default. If you prefer, you can usually choose to disable cookies by updating your browser or device settings to remove or reject cookies. For example, you may be able to disable cookies by following the instructions provided by your browser, which are usually located within the "Help," "Preferences" or "Settings" menus. If you want to delete any cookies that are already on your computer, please refer to the Help, Support, History or Tools area on your Internet browser for instructions on how to do so. Current technology does not permit your various devices to synchronize these settings, so you must set them for each browser and device that you use. You should know that if you choose to remove or reject cookies, or limit the use of other similar technologies, this could affect your access to all websites and in particular to the functionality of our Services. If you use your browser settings to block all cookies, you will block functionality cookies and may not be able to access all or parts of our website.
